REPORT FROM THE CHAIR, TONIA LARIVIERE

As Chair of the AAC, I first and foremost want to recognize the contributions of our members, each member brings diverse experiences, perspectives, compassion and passion to the committee. It is a profoundly rewarding experience to learn and contribute to advancements and awareness with them.

We need to thank our former Council representative, Councillor Andrew Knack for his commitment, guidance and generosity with his time, we are a stronger committee because of it. We are excited to have two new Council representatives, Councillor Keren Tang, and Councillor Jo-Anne Wright; although new to their roles they have listened compassionately and with intent to improve accessibility for all Edmontonians, we are fortunate and grateful to have their voices representing the committee on Council and we look forward to engaging with the new city council.

We would also like to publicly thank the Anti-racism Advisory Committee for their impressive work representing all of the City of Edmonton equity-seeking committees regarding the importance, necessity and value of our work; and we extend a generous thank you to City Council for recognizing and valuing the efforts of all who contribute to these committees.

In this report, you will be able to see a list of items we worked on in 2021. Three of our key concerns continue to be transit improvements, snow and Ice control and accessible housing. We continue to advise on transit, in particular an improved para-transit system including improvements to DATS and accessible taxis. We spoke to Council and outlined our suggestions and concerns with the lack of accessible taxis. A report was recently commissioned by the city, the findings supported our concerns and suggestions. We are currently working in collaboration with other City of Edmonton equity-seeking committees to support the advancement and improvement of accessible taxis service and will continue to advise on approaches and solutions that will positively impact people with disabilities.

We can all appreciate the challenges of winter in Edmonton, where safety is concerned. For individuals with disabilities, the challenges of snow and ice present challenges that may feel as insurmountable as a windrow. We thank the city for continually engaging and consulting with the AAC on improvements to procedures and policy, and we will continue to advise for the safety and independence of individuals who experience disability.



Accessible housing is a topic that affects every Edmontonian, not just those with a current disability. We appreciate that the city has created an Affordable Housing Investment Plan which could benefit those with disabilities and we would like to see that expanded to include accessible housing. This is a topic of utmost importance that affects basic human rights, the AAC will continue to advocate and educate on matters of accessible housing but we cannot do this alone, we encourage everyone to think about your aging-in-place and the impacts of inclusion for your friends and family who are senior, injured or disabled as we work together to make Edmonton accessible for all.

The committee also worked diligently and thoughtfully on community engagement, it is an important component in our advisory role. The advancements of inclusion for all is a community effort and a societal responsibility, while the AAC is a committee of 15, we represent a community comprised of one-quarter of Edmontonians. Our collective

perspectives, experiences, frustrations and voices aligned can result in small, yet mighty triumphs and just advancements for inclusion. We will continue to engage with the community and bring our concerns forward to Council with purpose and intent.

Thank you to everyone who considered our perspective, respected our voices and contributed to an inclusive Edmonton.



MANDATE AND ROLE OF THE ACCESSIBILITY ADVISORY COMMITTEE

As an advisory body to Edmonton City Council, the AAC seeks to understand the unique accessibility and inclusivity needs of the Edmonton community, and how these needs relate to City Council's strategy and policy direction. The AAC undertakes a significant role in helping City Council address the manner in which its strategies and policies impact people with disabilities and provides advice on best practices for engaging Edmontonians with disabilities.

To undertake its mandate in the area of providing policy advice to City Council and City Administration, the AAC has identified the following as priority areas:

- 1. Advise** City Council and City Administration on policies, potential policies, or changes to existing policies that affect access and inclusion for persons with disabilities.
- 2. Participate in and support events** and opportunities that enhance overall awareness of inclusion and accessibility issues in Edmonton.
- 3. Engage** with broader communities of persons with disabilities in a meaningful way, and ensure that the AAC has the necessary information to undertake its advisory role.
- 4. Educate City Council, City Administration and the public** on issues and best practices around inclusion and accessibility.

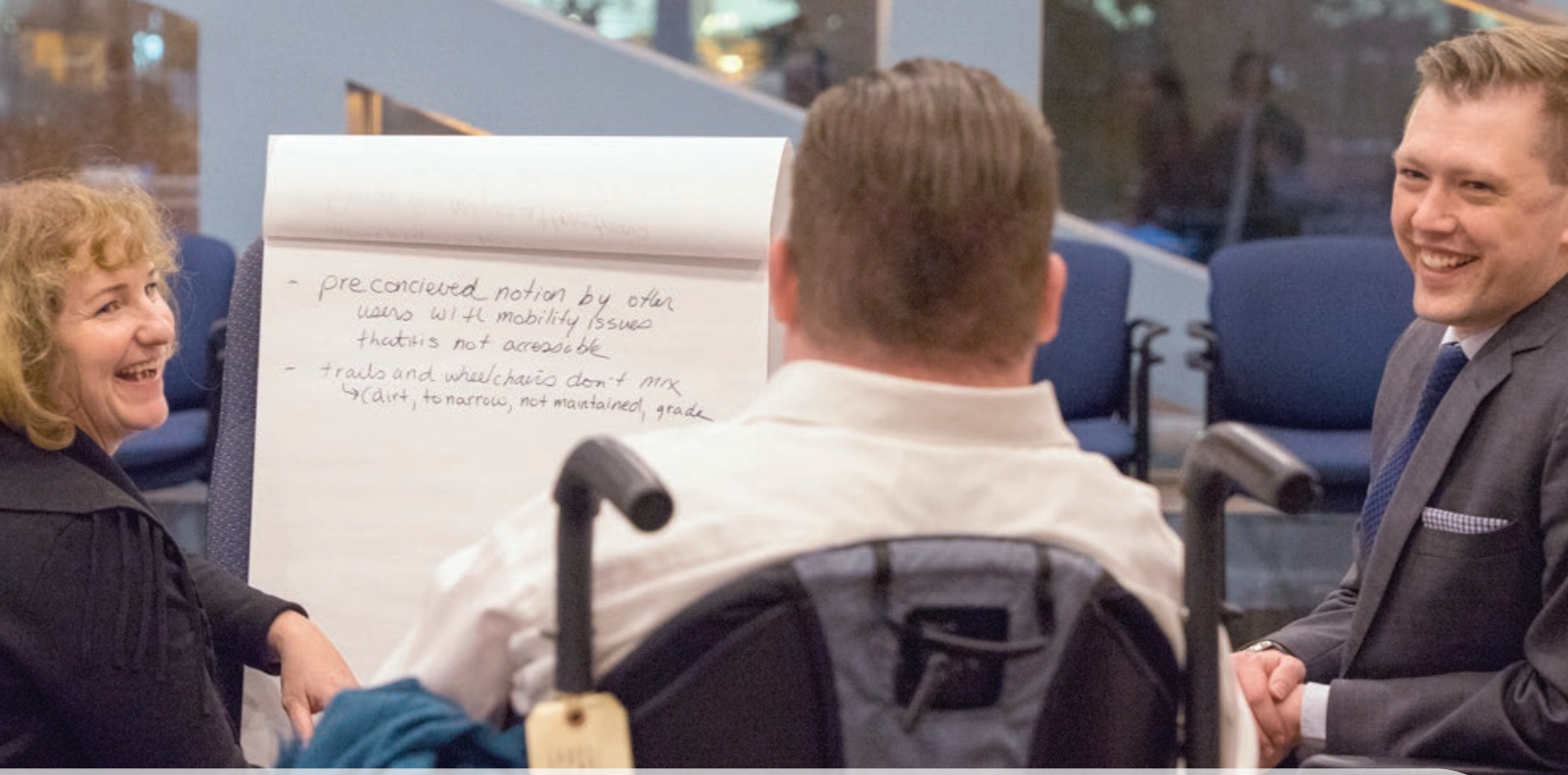

POLICY REVIEW SUBCOMMITTEE

Overview of the 2021 accomplishments:

- Updated the Checklist for Accessibility and Universal Design so it is aligned with the latest version of the Cities Access Design Guide
- Consulted with/advised Lime and Bird eScooter companies around accessibility concerns eScooters present on Edmonton streets and sidewalks
- Created an AAC language guide and incorporated into the bylaws
- Created a Group Expectations document to accompany the new committee code of conduct
- Met with the City Clerk's Office and learned about speaking to Council
- Continued advocacy around increasing accessible housing in Edmonton, with particular focus on the need for housing that is both accessible and affordable. Leger Consulting was engaged in a research report on 'Accessible Housing Research Study for People with Disabilities' designed to identify gaps between supply and demand in accessible housing. Research was completed in August 2021. Advocacy work continues on this issue.
- Continued advocacy around accessible taxis working with the Vehicle for Hire department. Pivotal Research Inc was engaged to do a needs assessment and study to improve the accessibility of vehicles for hire in Edmonton. Research was completed in late October with a presentation from the consultants complete with recommendations. Advocacy work continues on this issue.
- Participated in the Communications Review of the social identity and inclusion section
- Continued involvement with Policy C602 'The Accessibility for People with Disabilities Policy' implementation across departments
- Created Accessible Event Guidelines for City of Edmonton staff to use both internally and with external partners
- Advised on changes to the snow and ice control policy — advocating for more efficient and effective removal of snow from City streets and sidewalks as well as implementation of support for those residents who are unable to remove snow themselves

National AccessAbility Week (NAAW)

National AccessAbility Week celebrates the contributions of people with disabilities and functional impairments. The celebration recognizes the efforts of individuals, communities and workplaces to enhance inclusion by removing barriers. NAAW aims to act as a tool for social change by creating conversations around the issues of education, transportation, housing, employment and recreation across the Country.

Many organizations plan events throughout the week of May 28th to June 3rd to celebrate and recognize the efforts of individuals and groups making our communities more welcoming and accessible.

Support of the International Day of Persons with Disabilities (IDPD)

The International Day of Disabled Persons was proclaimed in 1992 by the United Nations General Assembly in Resolution 47/3. The annual observance of the International Day of Disabled Persons, 3 December, aims to promote an understanding of disability issues and mobilize support for the dignity, rights and well being of persons with disabilities. It also seeks to increase awareness of gains to be derived from the integration of persons with disabilities in every aspect of political, social, economic and cultural life. The theme of the Day is based on the goal of full and equal enjoyment of human rights and participation in society by persons with disabilities, established by the World Programme of Action concerning Disabled Persons, adopted by the General Assembly in 1982. As of December 18th, 2007,

the UN changed the name from International Day of Disabled Persons to the International Day of Persons with Disabilities. Nothing About Us Without Us was the theme of this year's International Day of Persons with Disabilities.

The AAC partnered with the Edmonton IDPD committee and helped bring together the many individuals, organizations and governments associated with persons with disabilities for one day of celebration within Edmonton IDPD Zoom Event 2021 on moving from recreational to competitive sport.
