- 4. I understand that the City of Edmonton may issue more Taxi/ Accessible Taxi Vehicle Licences at any time or times in the future.
- 5. I understand that the City of Edmonton may create and issue different classes of Taxi/ Accessible Taxi Vehicle Licences at any time or times in the future.
- 6. I understand that the number of Taxi/ Accessible Taxi Vehicle Licences issued by the City of Edmonton may increase over time.
- 7. I understand that the City of Edmonton may demand that my Taxi/ Accessible Taxi be driven for a minimum or maximum amount of time in a year in order to keep my Taxi/ Accessible Taxi Vehicle Licence.
- 8. I understand that the City of Edmonton recommends that I obtain independent legal advice before submitting this document to the City Manager for approval.
- 9. I understand that even if this application for transfer is approved, I still need to apply for and be issued the licence within sixty (60) days of the date endorsed hereon approving the transfer. I understand that if I fail to do so, the licence will not be issued to me, and I will not have any right or claim to the licence.
- 10 I understand that I need to comply with all requirements of the Vehicle for Hire Bylaw 17400.
