Eligibility

Organization or group with a valid registration number in Edmonton and surrounding areas that employ a minimum of five (5) permanent, temporary, full time or part time employees.

Any subsidiary companies must apply separately. For franchises the head office/district managers must submit an application on behalf of individually owned franchises.

Discounts for Employees

Eligible staff will have access to the following discounted memberships and admissions.

- 20% off annual and continuous monthly memberships
- 15% multi admission (5+) passes

Memberships

We offer two types of memberships for your staff and their household members - Value and Benefits Plus - each packed with great benefits, discounts and no hassle-terms. For more information about our memberships, visit edmonton.ca/NewMemberships.

To purchase a membership, employees must visit their nearest facility and provide a letter of employment or paystub to verify eligibility. Staff who select Continuous Monthly Memberships may be notified periodically to provide updated employment status. Annual membership holders will need to provide proof of employment at renewal.
