Official's Licence Application Information Guide

To officiate at ECSC sanctioned events, Edmonton Combative Sports Bylaw #15594 requires individuals to hold a valid official's licence. The following outlines key details for the official's licence application process:

Officials Licence Overview:

- 1. Annual Official's Licence fees range from \$50.00 to \$200.00.
- 2. One time annual payment with licence valid until the end of the calendar year
- 3. An Official's Licence application form is provided on the City of Edmonton website (www.edmonton.ca) under Edmonton Sports Commission, 'forms'.
- 4. All official's licence applications go through a review and approval process before a licence is issued. Applicants are evaluated on a number of factors, included, but not limited too: experience, training, references, skills, attitude and teamwork
- 5. An individual can hold more than one officials position with the ECSC; however, they pay for the licence classification with the highest fee
- 6. Holding an official's licence does not guarantee an official will work a particular event. Selection of officials for events is at the discretion of the Executive Director

Officials Licencing Requirements

- □ Event Referee or Event Judge Licence Fee \$200.00
 □ Event Referee or Event Judge Licence Fee \$100.00 (Boxing Only)
 □ Event Ring General Licence Fee \$200.00
 □ All other Officials Licence Fee \$50.00
- 1. Applicant's name, address and contact information
- 2. Gov't issued picture identification
- 3. Summary of combative sports officiating, training, and experience
- 4. Provide references
- 5. Voluntary disclosure about previous disciplinary information by a governing combative sports commission or authority
- 6. Voluntary disclosure about criminal charges or convictions
- 7. Voluntary disclosure about previous combative sport promotion
- 8. Applicants must acknowledge the following information:
 - The City of Edmonton's authorization to consult relevant stakeholder agencies or share information obtained in the application
 - ii. Relevant policies, procedures and Code of Conduct
 - iii. Event participation rules
